Audit Findings

The on-site visit for the Prison Rape Elimination Act (PREA) compliance audit of Kintock Bridgeton, (Kintock), located in Bridgeton, New Jersey (NJ), was conducted 03/06-03/07/2018 by The Nakamoto Group, Inc. certified auditor James L. Roland Jr. An in-briefing meeting was held with the Site Administrator, Corporate Compliance Officer, Program Director/Work Release/Acting Bureau of Prisons (BOP) Director, Program Director/Treatment, Director of Operations, Corporate Director/Facilities, Corporate Training Coordinator and the Corporate Director/Training. The standards used for this audit became effective August 20, 2012. This auditor discussed the information contained in the Pre-Audit Questionnaire with the facility PREA Coordinator. The Corporate Chief Executive Officer and the Corporate Director/Quality Assurance/PREA Coordinator were interviewed telephonically. As part of the audit, a review of all agency and local facility PREA policies was conducted, as well as a tour of the facility.

A total of 26 residents were interviewed, which included two disabled residents, one resident with vision and mobility impairment and one resident with cognitive impairment. No residents self-disclosed as being members of the LGBTI community and no residents were Limited English Proficient (LEP). The facility has no segregated housing and no youthful residents are housed at the facility. No residents reported sexual victimization during the risk screening process. One resident refused to be interviewed.

A total of 28 staff were interviewed, to include staff from all three shifts, five administrative staff, one contract medical staff person and eight specialized staff. The administrative staff interviewed included the PREA Coordinator, Site Administrator, Program Director/Treatment, Corporate Director/Facilities and the Human Resource Administrator (HRM). A tour was conducted of the entire facility and included all living areas, support services and all operational areas. During the tour, the auditor was accompanied by the PREA Coordinator, Site Administrator, Program Director/Treatment and the Director of Operations.

During the auditing period, there were no allegations of sexual abuse or sexual harassment.

Facility Characteristics

Kintock Bridgeton opened in 1999 and is located adjacent to South Woods State Prison. The facility houses minimum custody residents and has a design capacity of 531. The current resident population is 432. The facility employs 103 staff. The facility includes two single-story buildings housing adult men and women. At the time of this audit, the facility only had one female resident. Each building includes five housing dorms split into four pods to accommodate approximately 48 residents. There are a total of ten resident bathrooms (with showers, sinks and toilets); all showers and toilets have privacy curtains and doors. Laundry facilities, telephones, recreation areas, computer labs, class rooms, private counseling rooms and libraries are located in each building for resident use. Residents also have access to weekly contracted commissary and check cashing services. Building I provides space for work release services for the BOP contract. In addition, it houses male and female residents and the licensed treatment services for the New Jersey Department of Corrections (NJDOC) program for adult males. The program is licensed by the Division of Mental Health and Addiction Services. In Building II, The Kintock Group Bridgeton facility provides work release services to adult males via a NJDOC work release contract and to parolees via the New Jersey State Parole Board (NJSPB) contract, "Stages to Enhance Parole Success." Resident living areas are separated by these contracts.

Kintock Policy 3.05, PREA Sexual Abuse/Assault, clearly meets the mandates of this standard. The agency's zero tolerance against sexual abuse is clearly established and the policy also outlines the agency's approach to preventing, detecting and responding to sexual abuse and sexual harassment allegations. There is a National PREA Coordinator who is assigned in the agency to ensure adherence to the PREA. The Agency-Wide PREA Coordinator also serves as the PREA Compliance Manager. Zero tolerance posters are displayed throughout every area of the institution. Both institution staff and residents are provided with a wealth of opportunities to become well aware of PREA policies and procedures. Staff members receive initial training and annual training, as well as updates throughout the year.

The contact between the NJDOC and Kintock outlines the mandates of this standard. The contract requires each facility to review the staffing plans on an annual basis. Interviews with the Site Administrator and executive staff confirm compliance with the PREA and that other safety and security issues are always a primary focus as they consider and review their respective staffing plans. The Site Administrator meets daily with his executive staff to address staffing issues as it relates to the PREA. The facility has been provided with all necessary resources to support the programs and procedures to ensure compliance with PREA standards. The audit included an examination of all video monitoring systems, staff interviews and rosters. Supervisory/Administrative staff members routinely make unannounced rounds covering all shifts and these rounds are documented. Interviews with staff confirm unannounced rounds to all areas of the facility occur on a weekly basis, with no warning to staff. Kintock is a minimum security facility with video cameras visible throughout the facility. The facility does have convex mirrors to aid in areas where there are numerous corners. Staff supervision was also increased in those specific areas to enhance resident security.

Kintock Policy 8.02 (d) and 11.08 (a) and (e) address the requirements of this standard. Cross-gender strip or cross-gender body cavity searches are prohibited, except in emergency situations or when performed and documented by a medical practitioner. Staff indicated they received cross-gender pat search training during initial and annual training. The auditor observed that each unit has individual shower stalls for privacy while showering. The facility has implemented a policy that all staff of the opposite gender working the unit will announce themselves prior to walking the unit to allow residents the opportunity to prepare themselves from a privacy perspective. The majority of the residents interviewed acknowledged they are allowed to shower, dress and use the toilet privately, without being viewed by opposite gender staff. Staff, along with the majority of the residents interviewed, indicated that employees of the opposite gender announce their presence before entering a housing unit. Staff were well aware of the policy prohibiting the search of a transgender or intersex resident for the sole purpose of determining the resident's genital status. During the past 12 months, there were no exigent circumstances requiring cross-gender viewing of a resident by a staff member at the Kintock Complex.

PREA handouts, bulletin board postings and resident handbooks are in both English and Spanish. The above mentioned documents were submitted to and reviewed by the auditor. Employees interviewed were well aware of the policies that, under no circumstances, are resident interpreters or assistants to be used when dealing with PREA issues. The Kintock Group has set up a blanket purchase agreement for on-demand over-the-phone interpreter services, which are available to all Kintock residents. Lingualinx provides this service for residents who do not have a basic command of the English language. The auditor called the Lingualinx number and determined that it was in working order. There were no LEP residents housed at the facility during this audit. Documentation reviews and staff interviews support a finding that the facility is in compliance with this standard.

A tracking system is in place to ensure that updated background checks are conducted every five years. Policy clearly states the submission of false information by any applicant is grounds for termination. Kintock makes its "best efforts" to contact all prior employers for information on substantiated allegations of sexual abuse or resignations which occurred during a pending investigation of sexual abuse. The agency also provides information on substantiated allegations of sexual abuse/sexual harassment on a former employee, when requested from an employer for whom such employee has applied to work, unless prohibited by law.
